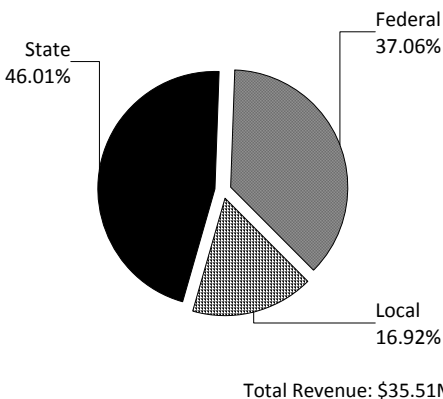

Revenue Sources



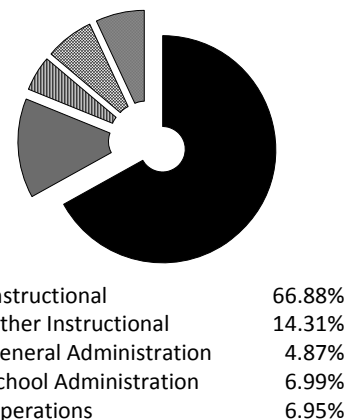
